## 6. **Scholarships and Grants**\*\*\*

- a. Active Parishioner St. Elizabeth Ann Seton Scholarship - \$1500 per child, per year. To qualify a family must be a registered member of St. Elizabeth Ann Seton, Santa Maria Del Mar, or another diocesan parish, attend weekly Sunday Mass as a family, and contribute a minimum of \$520 per year through regular, weekly donations to the home parish, which is confirmed through the parish business office. Failure to meet scholarship requirements in a review of scholarship eligibility may lead to loss of current and/or future Parishioner Scholarship funds. Deadline to apply is April 1, 2023. Apply through FACTS Grant and Aid and complete parishioner form, obtained through school office.
  
- b. Step Up for Students Scholarships - Amount varies  
St. Elizabeth Ann Seton Catholic School accepts the Florida Tax Credit (FTC), Family Empowerment (FES), and FES-UA (case by case basis). All families who may qualify are encouraged to apply at [www.stepupforstudents.org](http://www.stepupforstudents.org) or [www.aaascholarship.org](http://www.aaascholarship.org). Please contact the school office at 386-445-2411 for further information about scholarships.

*\*\*\*Families who qualify for the above scholarships are responsible for the payment of the differential between full tuition and scholarship received. This may be done through a payment plan on FACTS. Families can receive only **one** scholarship.*
